X2 Meavy Oaks, Yelverton, PL20 6PJ. Following a site meeting with the Tree Officer and Devon Tree Services on Thursday 24th January 2019 the following work has been discussed and agreed:		
T1 - Veteran oak (Meavy oak). 1. Significantly reduce x2 secondary branches emanating from largest south-southeast primary branch; 2. Reduce remaining lesser secondary branches within canopy as required to suit wind loading. The aim is to reduce overall weight/loading on the severely decayed main stem whilst attempting to retain as much photosynthetic material as possible. Ivy will also be removed so that covered areas can also be inspected.	400.00	80.00
T2 - Mature oak opposite The Royal Oak pub. 1. Reduce secondary branch (with 2 branch tear wounds) growing northwest in the direction of the Church. Reduce this branch back to small diameter secondary branch between the two wounds. 2. Reduce ascending secondary branch growing north towards the pub to minimise wind/branch end loading. 3. Crown lift to provide statutory road clearance heights.		
All arising material shall be removed from site and returned to our premises for recycling.
